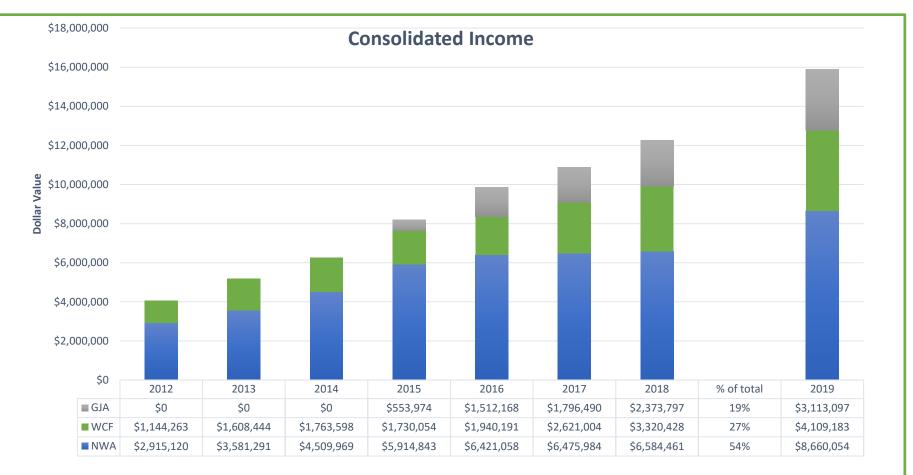

Entity & Year

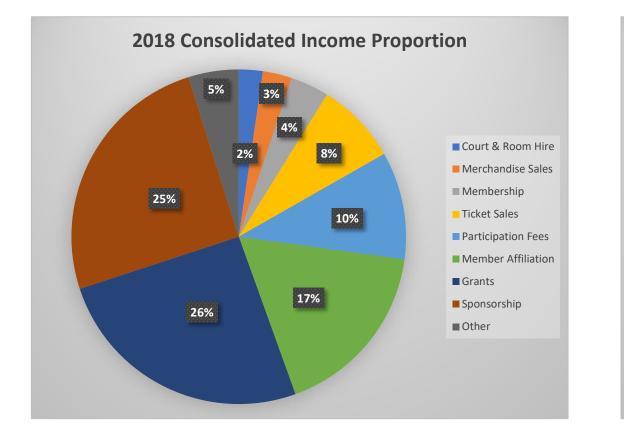


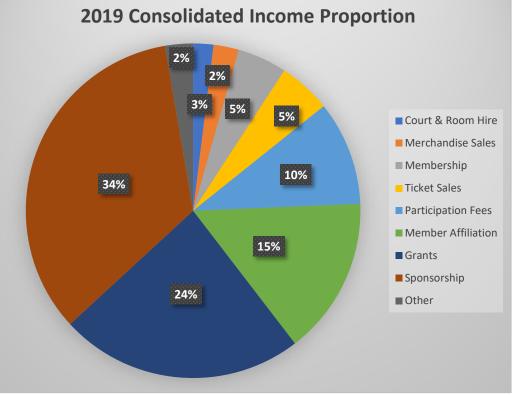


Financial Overview - Revenue

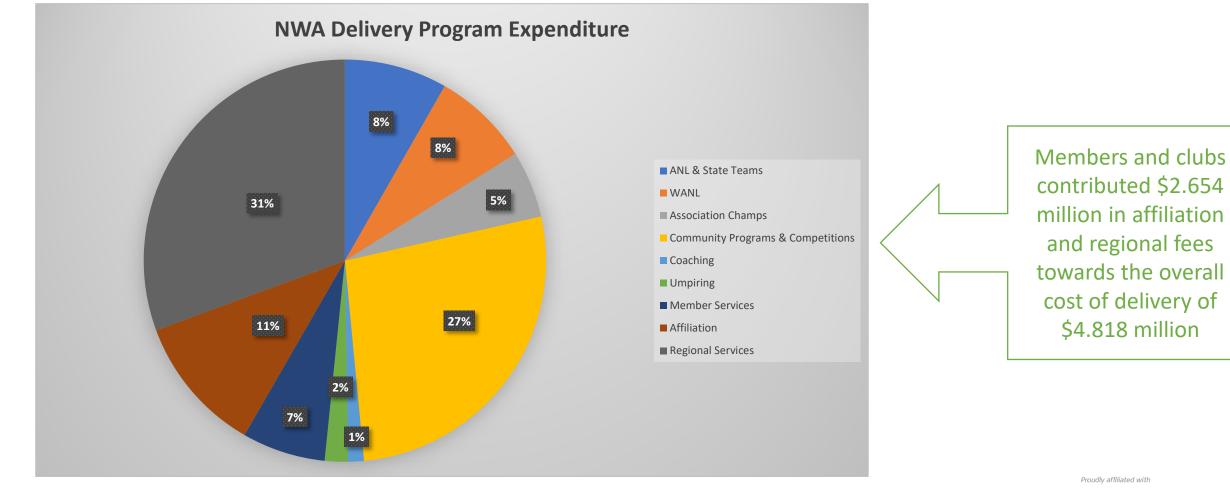




Financial Overview – Expenditure





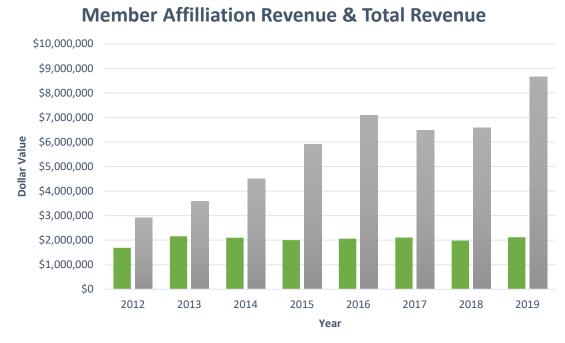
