# UPDATE ON REVISED NETBALL WA 2020 FEE STRUCTURE & OTHER KEY DATES

The impact of COVID-19 has required Netball WA to revisit and review its 2020 fee structure, specifically the individual membership and Suncorp NetSetGO fees. Feedback from Association and Gold Industry Group WANL Club Presidents, Netball Australia and Netball WA staff was included in this review and presented to the Netball WA Board for their consideration. The Netball WA Board recently endorsed the following outcomes for the remainder of the year:

# **Individual Membership Fees**

A new 'Individual first competition membership fee' structure will be introduced for 2020. This new fee structure is based on the 2020 Individual Short Season Fees and includes a 25% reduction to Individual Small Country Association Fees. In addition, a modest flat fee for all categories of membership for the 'Individual second competition membership fee' will also be introduced for the remainder of the year. The new fees are outlined below and in Appendix A:

- Senior Full & Short Season first competition fee
- Senior Full & Short Season second competition fee
- $\circ\quad$  Junior Full & Short Season first competition fee
- **o** Junior Full & Short Season second competition fee
- Senior Small Country first competition fee
- Senior Small Country second competition fee
- Junior Small Country first competition fee
- Junior Small Country second competition fee

The agreed changes will be applied as follows:

- The Competition Fee is an Individual Membership type that will apply to all current registration types in MyNetball.
  - The individual first competition membership fee will be for members' primary playing registrations.
  - The individual second competition membership fee will be applied to members' secondary playing registration. This will exclude those whose secondary registration is due to Origin Energy Metro League or Gold Industry Group WA Netball League player registrations.
- The affiliation period shall be from the date of registration and will end once the competition has been completed or the individual member is no longer participating in that competition.
- Competitions that run into 2021 must be discussed with Netball WA for approval.

### Suncorp NetSetGO Fees

The Netball WA Board agreed that the Suncorp NetSetGO Participant fees will remain unchanged as outlined below and in Appendix B:

### Suncorp NetSetGO Information

- Suncorp NetSetGO is a Netball Australia product and Netball WA holds the licence to approve and/or operate all Tiers of the program within Western Australia.
- Netball Australia has made the decision not to accept any participant withdrawals (unless they meet the current withdrawal criteria, and this currently does not cater for the COVID-19 impact). They have also maintained their Participation fee (inclusive of program participant pack) of \$25.30 for every primary participant who is either currently registered or will register for the program in 2020.
- Please note, participants who have registered and submitted a withdrawal that does not align with the current Suncorp NetSetGO withdrawal criteria, will be liable for the payment of the Netball Australia Participation fee.
- As part of its Digital Playbook Strategy, Netball Australia has developed a Suncorp NetSetGO virtual program for all participants to access and engage in, particularly during this COVID-19 period. This program will not take the place of face to face delivery; however, it will be an additional program offering to this community.
- Please note that the Netball WA component of the Suncorp NetSetGO Participant fee is \$37.00 (GST incl) for a primary participant and \$23.00 (GST incl) for a secondary participant.
  - If a participant chose to do one program in 2020, the fees payable to Netball WA (excluding Netball Australia's Participation fee of \$25.30 GST incl.) will be \$37.00 (GST incl.), which is less than the proposed NWA junior membership competition fee across all categories.
  - If a participant chose to do two Suncorp NetSetGO programs (i.e. winter and spring) in 2020, the primary and secondary fees payable to NWA (excluding Netball Australia's Participation fee of \$25.30 GST incl.) will be \$60.00 (GST incl.) which is slightly more than a Junior Small Country competition fee but less than the other categories of Junior competition fees.
  - Given the competition format information received from small country associations thus far, it is expected that most, if not all small country associations will only run one season/program for 2020.

### **Other Netball WA Fees**

Please note that all other Netball WA affiliation, membership and participation fees will remain unchanged. The updated 2020 Netball WA Affiliation, Membership and Participation Fee Structure Appendices A to D can be found at the end of this memo.

# **Other Key Dates**

# **Return to Community Netball**

Netball WA released its Return to Community Netball Guidelines, Roadmap and Return to Training Protocols (Phase 2) on Friday 15 May. Whilst it was confirmed that a return

to training could commence from Monday 18 May, this was conditional on the required guidelines and protocols being completed by all parties. Thereafter, associations and clubs must ensure that these and any other requirements are managed and adhered to at all times.

All affiliated associations, clubs, and Suncorp NetSetGO Centres are reminded that a return to competition date and any further guidelines and protocols relating to Phases 3 & 4 of the NetballWA Roadmap have not been confirmed as yet. Netball WA is expecting further announcements by both the Federal and State Governments by the 8 June 2020 after which time, further information will be provided to our community.

Whilst associations and clubs continue to plan for the start of competition, we remind everyone that community netball competition is not permitted until further notice.

### **Member and Participant Registrations**

The registration of individual members and participants is paramount, and all affiliated associations and clubs **MUST** ensure that their players, participants, committee members, coaches, officials, and volunteers are registered to the corresponding membership and participant categories in MyNetball. Netball WA reiterates that this process **MUST** be completed prior to any return to training by an individual member or participant.

# **APPENDIX E: Individual Membership Competition Fees Scenarios**

Below are several scenarios outlining how each of the individual competition membership fees will be applied within a competition environment.

### Scenario 1

Player A is a full senior member from a large metropolitan association, and they have registered to play in a winter competition only, that is likely to commence in July and finish in late September. Therefore, their first competition membership fee payable to Netball WA would be \$67.00.

#### Scenario 2

Player B is a full junior member from a regional country association, and they have registered to play in a winter competition (July to September) and will play in a spring competition (October to December) as well. Therefore, their competition membership fees payable to Netball WA would be \$66.00 and \$11.00 for the first competition and second competition, respectively.

#### Scenario 3

Player C is a small country junior member from a small country association, and they have registered to play in a winter competition only, that is likely to commence in late June and finish in early September. Therefore, her first competition membership fee payable to Netball WA would be \$53.25.

#### Scenario 4

Player D is a short season senior member who will participate in their local association's spring season from October to December. It is the first and only competition that they will participate in for the year. Therefore, their competition membership fees payable to Netball WA would be \$67.00.

#### Scenario 5

Player E is an Origin Energy Metro League player who participated in the Origin Energy Metro League 2020. However, they had already registered to play in their association's winter competition as a full junior member earlier in the year. Therefore, their competition fees payable to Netball WA would be \$66.00 for the first competition (winter), as this was their primary registration in MyNetball.

#### Scenario 6

Player F is an Origin Energy Metro League player who participated in the Origin Energy Metro League from February to March 2020 and is now not playing in an association's winter competition as a full senior member due to COVID-19. Therefore, their competition membership fee payable to Netball WA for the first competition would be \$67.00.

#### Scenario 7

Player G is a full senior member who will only participate in the Gold Industry Group WANL competition from July to October in 2020. Therefore, their competition membership fee payable to Netball WA for the first competition would be \$67.00.

#### Scenario 8

Shootina **Stars** 

Player H is a full junior member who has registered to play in their association's one and only competition for the year, which runs from July to November. Therefore, their first competition membership fee payable to Netball WA would be \$66.00.
