## PERTH NAIDOC NETBALL CARNIVAL

### SUNDAY 15 NOVEMBER 2020

#### BACKGROUND

Netball WA (NWA) will be celebrating its 17<sup>th</sup> year as hosts of the **Perth NAIDOC Netball Carnival**. The annual event, which began in 2004 with 20 teams, has now grown to include over 110 teams each year.

#### PURPOSE

The NAIDOC Netball Carnival forms part of **NAIDOC Week** celebrations, whereby Aboriginal and Torres Strait Islander netball players from across Western Australia are invited to participate in the annual NAIDOC Netball Carnival.

The carnival is held annually at the Gold Netball Centre, and staged in conjunction with the Department of Local Government, Sport and Cultural Industries, the NAIDOC Netball Carnival is both an opportunity to showcase the skills of Aboriginal and Torres Strait Islander netballers to competitive netball, as well as a platform to increase awareness and education around health promotion, health prevention and care benefits for Indigenous people.

#### COVID-19 Phase 4

- a) NWA reserves the right to make alterations of this Handbook at any point to best suit the Competition and the COVID-19 safety protocols directed by the state government.
- b) As per the current State Government directions, the 2020 Perth NAIDOC Carnival will be run under Phase 4 COVID-19 Protocols.
- c) **Please be aware that during Phase 4, patron capacity limits must be adhered to at both Perth Netball Association (PNA) and Gold Netball Centre (GNC) Venues. Patron numbers will be monitored throughout the day of the event to ensure this is correctly maintained.**
- d) At this stage there is no restrictions on spectators per team, however, please note this is subject to change and this will be communicated by Netball WA. However, it is strongly encouraged that teams limit the number of spectators on the day and that teams and spectators arrive for matches as early as possible on the day.
- e) For all matches played on PNA and GNC courts, the losing team is required to wipe the goal post pads with disinfectant wipes immediately after the match has finished.

- f) A packet of disinfectant wipes can be found at every allocated court to be used for this cleaning. The wipes are to remain on the sideline (in line with the centre circle and with the scorer and timer) of this court for the entire day and not to be taken from this location.
- g) These wipes can also be used by teams to disinfect their match ball after matches have been played.
- h) **Please see the following additional protocols in place for the 2020 Perth NAIDOC Carnival. Ensure all participants, officials and supporters are aware of these rulings.**
  - a. Physical distancing of 1.5 m must be maintained, along with 1 person per 2spm whilst not participating match play.
  - b. All equipment is to be thoroughly sanitised after each game.
  - c. NO PERSON is to attend the carnival if they are sick, have a temperature, feel unwell or if they have been in contact with another person who has been sick. The team coordinator should be notified immediately of any of the above.
  - d. Alcohol based sanitisers must be available for all groups/teams for match play, for use prior, during and following match play.
  - e. Staff are to use sanitiser on arrival, and before leaving the carnival. NWA will be providing sanitising stations throughout the venue in which hand sanitiser will be available for use.
  - f. All drink bottles must be clearly labelled and must not be shared. Drink carriers are not to be used for drink bottle storage.
  - g. No sharing of towels.
  - h. Sharing of food is not permitted.
  - i. High fives, handshakes or other physical contact is not permitted.
  - j. NWA recommend that each team have their own first aid kit which contains gloves
  - k. **General Hygiene Protocols**
    - i. Avoid close contact with people who are sick
    - ii. Stay home and seek medical treatment when you are sick
    - iii. Avoid touching your eyes, nose and mouth
    - iv. Wash your hands often with soap and water for at least 20 seconds – If soap and water are not available, use an alcohol-based hand sanitiser
    - v. Cover your mouth with the pit of your elbow to cough or sneeze.

### 3. Check-in Process and Team Pack Collection

- One representative from each team must check in at the Registration and Team Bag Collection point between 8:00am – 8:30am on **Sunday 15 November 2020**.
- The Team Pack collection point will be outside the main entrance gates to PNA (See *Appendix 3: Venue Map*).
- This representative will be required to collect the Perth NAIDOC Netball Carnival team pack from this collection point.
- The team pack will include the following items: carnival handbook, fixtures, scoresheets, instructions, match ball and other relevant information related to the competition.

#### 4. Entry and Exit Protocols

- a) Team and Spectator entry to the venue is via the gates on the southern side of Perth Netball Association only (*See Appendix 4: Entry and Exit Map*).
- b) Teams are encouraged to gather outside the venue as a team and enter as one group together.
- c) Upon arrival, teams will be directed by Grounds Coordinators towards a specific court for the commencement of the Opening Ceremony.
- d) Prior to the weekend, each team will be provided with a map of the GNC and PNA courts and this will also be provided in Team Packs. It is the responsibility of each team to ensure that all participants understand the location of their courts for their matches. Court allocations will be provided on the fixtures that will also be sent out to teams prior to the event.

#### 5. Opening Ceremony

- a) The Opening Ceremony will be held at 8:30am on **Sunday 15 November 2020**, prior to the commencement of the Round 1 fixture.
- b) The ceremony will be conducted on the outside courts at the Perth Netball Association venue.
- c) Further details will be supplied closer to the date as to where teams will be asked to assemble.
- d) Teams will be instructed to remain physically distant from other teams during this ceremony.
- e) Teams will be encouraged to bring their team or Grassroots Site banner/signage with them to the Opening Ceremony.

#### 6. Closing Ceremony / Presentation

- a) Presentations will take place at approximately 4:50pm on **Sunday 15 November 2020** immediately following the conclusion of the last time slot.
- b) Winning teams are asked to assemble on GNC Court 1 ready for the commencement of the Presentation/Closing Ceremony, with other teams and spectators positioned in the grandstands.
- c) Teams will be instructed to remain physically distant from other teams during this ceremony.
- d) Only the winning teams, MVP (for each age division) and Grand Final MVP recipients will receive awards at the closing ceremony.
- e) Only one representative of each winning team will be asked to collect the winning medals on behalf of their team.



## 7. Aboriginal Grassroots Program

- a) Netball WA provide subsidies to the ten (10) Netball WA Aboriginal Grassroots Programs that involve multiple regional sites all over Western Australia.
- b) Netball WA provide full registration fee cover for five (5) teams per program site. Additional team registrations will be \$100 per team.
- c) Netball WA encourage that each site includes participants that are consistently involved in the program to be included in their team nominations.
- d) Netball WA source umpires for the program sites.

## 8. Sports Medicine Personnel

- a) First Aid services will be available on the grounds at the Gold Netball Centre and Perth Netball Association venues.
- b) The responsibility of the First Aid personnel is to assist with on-court injuries or injuries after the player has been removed from the court.
- c) Only NWA and/or venue officials are to call for an ambulance and to advise safe entry to the venue. This is important to ensure multiple ambulances are not called for the same incident.
- d) First Aid post will be allocated outside the Eastern side of Gold Netball Centre (*see Appendix 3: Venue Map*)
- e) Please note no preventative strapping will be available.

## 9. Netball WA Injury Insurance

- a) The Perth NAIDOC Carnival Fee is inclusive of injury insurance for all players submitted via the registration process. Please note, cover is for the competition only. Players must be listed on score cards to ensure cover.

## 10. Protests & Complaints

- a) Any protest or complaint must be lodged in writing addressed to the NWA Competitions Coordinator.
- b) Should a protest or complaint relate to a particular match, it must be lodged by no later than thirty (30) minutes after the conclusion of the match.
- c) Protests and complaint forms will be made available at the Competitions/match offices and must include the team name, opposition team name, division, time, nature and details of protests or complaint, and the names of people involved.

## 11. Appeals Committee

- a) Appeals against game results shall be heard by the Appeals Committee, which shall consist of a Community Aboriginal Liaison Officer and at least 2 other Netball WA representatives from the following: NWA Participation Manager, NWA Participation Coordinator, NWA Competitions Coordinator or NWA Operations Manager. If any of these representatives are unavailable, another NWA representative will be appointed.
- b) **ONLY** the Captain of a team can request clarification or lodge an appeal to the Appeals Committee, at the first instance, to the Competitions Coordinator who can be found at the Match Office.

## 12. Photography

- a) Teams **must ensure** parents/guardians of any underage players in any team are aware that NWA will be taking photos and potentially filming during the competition as stated on the Team Nomination form.
- b) Please utilise the waiver found on the Team Nomination form whilst registering your teams.
- c) If a member of the team does NOT agree to the photography consent or they cannot have their image taken a Team member is required to complete the **Photography Opt-Out** section which is located on the Team Nomination Form under Player & Officials Registration form. This is to be submitted alongside the Team Nomination form by **COB Friday 6 November 2020**.

## COMPETITION STRUCTURE

### 1. Competition Format

The Event will comprise of the following groups:

- Open Masters
- Open Mixed
- Open Women
- 18U – Girls
- 16U – Girls
- 14U – Girls
- 12U – Girls

Expression of interest will be sought from the community for the following age groups:

- Suncorp NetSetGO (8 – 10 years)

### 2. Age Eligibility

- a) Proof of age will be requested if deemed necessary.
- b) Netball WA encourages all players to play in their specific age category during the Perth NAIDOC Carnival.
- c) Players turning 10 years of age (in year of competition) are not permitted to play in the 12U age group unless prior approval has been sought from NWA.
- d) Teams in all divisions (with the exception of master's and NetSetGO divisions) may play a player in a team up to 1 age divisions higher than their current age group. Example: 12U player may play in the 14U competition, provided developmentally they are capable of playing at the level. Ensure an Age Eligibility Exemption request form is

completed for this.

- e) For the Open Mixed Age Division, boys that are 16 or 17 years of age can apply for an Age Eligibility Exemption Request to compete in this division.
- f) Teams are not permitted to play a player down an age group during the Carnival.
- g) Any team playing an ineligible player will be **penalised two (2) points for each game where there was an ineligible player.**
- h) Teams that have extenuating circumstances in relation to any of the age eligibility rules must submit exemption request Forms (*See Appendix 2: Age Eligibility Exemption Request*). through email to NWA Participation Coordinator Jayme Harken [jayme.harken@netballwa.com.au](mailto:jayme.harken@netballwa.com.au) **prior** to the commencement of the carnival.
- i) Closing date for these request forms will be on COB **Friday 6 November 2020**. All submissions will be considered, with a decision confirmed by NWA by COB **Monday 8 November 2020**. NWA's decision will be final.

### 3. Player and Team Eligibility

- a) A **maximum of 12 players** per team may be registered through the team nomination form.
- b) All players must be registered as team players through the team nomination form as of the closing date of the form, **COB Friday 6 November 2020**.
- c) Only those listed on the team nomination form can play for that team (unless prior changes have been approved by Netball WA).
- d) There must be a minimum of 5 Aboriginal/Torres Strait Islander players per team on the court at any one time
  - a. A breach of this rule will be discussed by the appeals committee which includes the Community Aboriginal Liaison Officer for the event.
- e) For Mixed Opens teams, a maximum of 3 males can be on court at one time.
- f) Players who participated in the 2020 GIG WANL season are permitted to play within the 2020 Perth NAIDOC Carnival.
- g) NWA encourages all coaches to endeavour to give all players, particularly juniors, a fair amount of court time over the duration of the carnival as it is a community participation carnival.

### 4. Player Movement

- a) A player must commit to **ONE team** and **ONE age division** for the duration of the Carnival.
- b) Players cannot play within multiple teams.
- c) Player additions must be approved by the Participation Coordinator/Manager.
- d) If 12 players are listed on the team list, no additional players can play for that team

unless they are replacing an already listed player and this has been approved by the Participation Coordinator/Manager.

- e) If a player needs to be moved to a different team, please contact the Participation Coordinator/Manager.
- f) Should the Team Coordinator need to make any changes to the team after Team Nominations have closed, including player replacements, player changes or late additions (who are not listed on the team), teams must provide written application to the Participation Coordinator Jayme Harken [jayme.harken@netballwa.com.au](mailto:jayme.harken@netballwa.com.au)
- g) Final player changes must be emailed by **COB Thursday 12 November 2020**.

## TEAM NOMINATION

### 1. Team Entry

- a) All teams are required to complete the '2020 Perth NAIDOC Netball Carnival Player & Official Registration Form' and must submit this to NWA through email to the NWA Participation Coordinator Jayme Harken [jayme.harken@netballwa.com.au](mailto:jayme.harken@netballwa.com.au) by **COB Friday 6 November 2020**. Teams are entered via their respective Club or Team with all players and officials not having to be affiliated with NWA and meeting the respective Club or Team selection criteria.
- b) Club or Teams may nominate more than one team into the same age-group however the Competition Coordinator may implement a cap amount accordingly if deemed necessary, and their decision will be final.
- c) Upon Team Nomination, Teams must submit the name and contact details of their Coach and/or Manager/Assistant Coach.

### 2. Carnival Fees

- a) Netball WA will invoice each participating team with their Team Fee.
- b) Teams are to complete the Team Payment Details on the Team Nomination Form and submit this to NWA by **COB Friday 6 November**. NWA will complete this transaction of team fees on **Monday 9 November 2020**.
- c) Teams must be financial by this date to participate in the 2020 Perth NAIDOC Carnival.

## COMPETITION RULES & REGULATIONS

### Perth NAIDOC Carnival Netball Rules

The 2020 Perth NAIDOC Netball Carnival will be played under the rules outlined in the *International Netball Federation Rules of Netball* 2020 Edition, except with the amendment in game time (2x 12 min halves).

#### 1. Competition Format

- a) There will be five (5) minors round matches across the day.
- b) Teams will play all teams in their division within a Round robin format.
- c) Bye rounds may be required if divisions have uneven number of teams.
- d) At the end of the Round 5, the top two teams in each division based on the competition ladder will play off in a Grand Final match.

#### 2. Grading and Fixtures

- a) All efforts will be made to place teams in divisions according to nominations, however to ensure an even spread of teams across divisions and to best fit the Competition format, teams will not be guaranteed their preferred divisional allocation.
- b) **Netball WA will make the final decision on divisional grading and no further correspondence will be entered.**
- c) Team Nominations must be received by the specified due date to allow for fixture preparation.
- d) Fixtures will be distributed to the nominated contact and made available via email sent to teams prior to the event.
- e) Fixtures will be uploaded to the NWA website in addition to being on MyNetball.
- f) Where changes in fixtures occur teams shall be notified as soon as possible.

#### 3. Match Duration

- a) All games shall consist of two (2) x twelve (12) minute halves, with a 3-minute interval between the two halves.
- b) All games at both Perth Netball Association and Gold Netball Centre will be centrally timed.

#### 4. Stoppages/Injury Time

- a) Injury time applies as per the Official Rule Book:
  - *The player concerned must leave the court within 30 seconds and receive any treatment off the court.*
- b) As matches will be centrally timed, no extra time will be given for a stoppage during all fixtures.
- c) In the event of a serious injury where an athlete cannot be moved (i.e. unconscious, suspected spinal, etc.) the match office is to be notified immediately. Where possible the game will be moved.

## 5. Match Forfeits or delayed starts

- a) In the event of rain, all games will continue unless the conditions are deemed unsafe, in which case the NWA Competitions Coordinator will make announcement advising if games are being delayed or cancelled.
- b) Should a match be unable to commence due to the unavailability of the court for reasons beyond the control of competing teams, NWA where possible will reschedule the match.
- c) To take the court a minimum of five (5) players are required.
- d) At the time scheduled for the commencement of a match, if fewer than five players are present for either or both of the competing teams, a maximum period of six (6) minutes shall be allowed for at least five players of a team to arrive. For every minute that the team is not ready to play during the 0.00 – 5:59 minutes after the scheduled commencement of the match, the non-infringing team is awarded one (1) goal per minute (up to 5 goals).
- e) If, at the end of this time (6.00min from the start of the scheduled match time), there are fewer than five players present for one team, the offending team shall forfeit the match.
- f) A team shall forfeit a match in the following circumstances:
  - If the team advises the Match Office of its intention to forfeit.
  - If fewer than five players in either competing team are ready to commence play six minutes after the scheduled match commencement time.

- g) Any team forfeiting a match for any reason shall have the following penalty:

**[Penalty: the infringing team will be awarded zero points; the non-infringing team will be awarded two competition points and all players on the non-infringing team are awarded one game towards meeting minimum game qualification. Goal scoring will be awarded as 5-0.]**

- h) If a forfeit is announced, teams can still play on from this point, however umpires must record the game as a forfeit on the scorecard and indicate which team shall receive **the two points**.
- i) In the event of unforeseen and exceptional circumstances a match cannot be rescheduled or completed, without a team's fault, the following shall apply:
  - a. A **drawn** result will be declared if the game was stopped **prior** to, or **during** half time and each team awarded one match point, with scores at that time recorded.
  - b. If the game has **entered** the second half, a **win** will be awarded to the team with the highest score at the time in which the match was stopped, the winning team awarded 2 points, with scores at that time recorded.
  - c. In the event the match has **entered** the second half and score is tied at the time of the match being stopped, a **drawn** result will be declared and each team awarded one match point, with scores at that time recorded.
  - d. If the game has not commenced and cannot be rescheduled, a drawn result will apply, and each team will be awarded one point.



## 6. Match Points

a) Points will be awarded as follows:

Win	2
Loss	0
Draw	1
Won on Forfeit	2
Loss on Forfeit	0
Bye	0
Abandoned	1

## 7. Finals

- a) Final placings will be determined by the number of points accumulated after the fixtured matches.
- b) If two (2) teams have equal points after the last match in the fixtures, then the following method will be used to determine their placings:
  - *The goal percentages achieved by each team during the fixtured matches – highest to lowest (i.e. goals for divided by goals against multiplied by 100).*
- c) To qualify to play in finals, players must be registered in the team list and have participated in a minimum of three (3) matches for their team during the minor round matches of the Competition. This will be determined via the details entered on the scorecard.
- d) Any team that does not meet the Player minimum game requirements will not be eligible to play in the finals. It will be the responsibility of the Team Coordinator to ensure that only eligible players take the court during the Grand Final.
- e) The first mentioned team shall collect official score card from the Match Office for finals and shall provide the scorer.
- f) In the event of a draw in a Grand Final game, there shall be a one-minute break, during which time the umpires shall confirm with the scorer that the game is a draw.
  - Positional changes may **not** be made at this time.
  - The game shall recommence with the centre pass being taken by the team due to take the centre pass
  - The game shall proceed until one team has scored a two-goal advantage.
  - The scorer shall alert the umpires when this has occurred.

## 8. Match Balls

- a) 1x 2020 NAIDOC designed ball will be provided to each team within their team pack
- b) The match balls along with team packs will be available for collection at the Team Registration Desk outside the main entrance gates to PNA between 8:00am – 8:30am.

- c) These balls must be used as game day match balls.

## 9. Equipment

- a) All teams are to provide their own bibs
- b) It is highly recommended that each team also brings a set of 'clash bibs' in case they are playing another team with similar uniform colours
- c) In the instance, that teams can't supply bibs, NWA have **LIMITED** supply of bibs for teams to purchase.

## MATCH OFFICIALS - UMPIRES

### 1. Umpire Allocation:

- a) NWA will supply all nominated teams with umpires for minor round matches and Grand Final matches.
- b) It is the responsibility of the Umpire to be fully aware of the Rules and Regulations of the event and matches.
- c) All umpires participating will be a Netball WA registered and affiliated member prior to the commencement of the Perth NAIDOC Netball Carnival.
- d) Umpires are to decide on the two (2) best players from the game and record it on the back of the scorecard prior to it being signed.

## TEAM OFFICIALS

### 1. Coach and Manager Criteria and Mentoring

- a) Each Team must nominate one (1) Coach with the OPTION of allocating one (1) Manager per team and may nominate up to one (1) Assistant Coach per Team.
- b) All Coaches and Managers are NOT required to hold or obtain a current National Coaching Accreditation.
- c) All Coaches and Managers REQUIRE a valid or current Working with Children's Check prior to the commencement of the Carnival to be eligible to coach or work with the team.

### 2. Scoring and Timing Procedures

- a) All matches, including Grand Final matches, will be central timed by Netball WA from either the Perth Netball Association Match Office (for matches on PNA courts) or from the Gold Netball Centre Match Office (for matches on GNC courts).
- b) One (1) scorer must be supplied by each team for each match.
- c) The first mentioned team on the match fixture shall provide the score card (supplied in Team Packs) and a scorer for that match.
- d) Please ensure that personnel allocated to these duties are competent in the procedures.
- e) The scorer must stand opposite the centre circle on the side-line throughout the match.

- f) Should the initial scorer be required for another duty, an alternative scorer must be used immediately to avoid any discrepancies during this time frame.
- g) Umpires are to check scores at half time and at full time to ensure there are no discrepancies.
- h) For records and insurance purposes, the names of participating players must be recorded on each scorecard **prior** to the commencement of the corresponding game.
- i) Team lists on the scorecard shall list up to twelve (12) players.
- j) Player additions after the commencement of the match are not permitted. If a name is added after the commencement of the game the following penalty applies:

**[Penalty: forfeiture of the game]**

- k) One official from each team are responsible for recording the team changes at half time and recording which players played each half.
- l) The information is to be recorded on the scorecards for the purpose of tracking player participation across the event.
- m) Umpires, the scorer and both team captains are to sign the scorecard.
- n) Scores on the signed scorecards will stand, no further discussion will be accepted.
- o) The winning team is to return the scorecard to the score box near the Match Office immediately after each game – outside courts (PNA Match Office) and GNC indoor courts (GNC Match Office).
- p) Failure for the scorecard to be returned by the winning team within one (1) hour immediately after the scheduled game will result in the following penalty:

**[Penalty: Loss of two competition points to the offending team – the goals for and against shall remain as scored for both teams]**

- q) Official score card for Grand Final games shall be collected by the first mentioned team before the match from the relevant Match Office.

## VENUE AND EVENT OPERATIONS

### 1. Amenities

Public change room facilities (toilets and showers) will be available at the Gold Netball Centre and Perth Netball Association.

### 2. Venue Canteen Operation

- a) The Gold Netball Centre kiosk will be open all day. There will be a variety of food options for participants.
- b) Two Queens and Boost Juice will feature as a food vendor at the carnival and will be present all day.

### 3. Official Merchandise

Netball WA, in association with our apparel partner ISC, will be providing a range of official Netball WA and West Coast Fever merchandise for participants to purchase. The merchandise range will be available to purchase prior to the event and post event as well as during the event from the official merchandise stand.

### 4. Car Parking & Traffic Management

- a) NWA & PNA will work with together to develop a comprehensive Traffic Management Plan to ensure the safe and effective movement of all participants and spectators from cars and buses to and from the venue.
- b) Limited number of parking spaces are available on site due to other sports. Large buses and coaches **WILL NOT** be permitted to park in this area. (*See Appendix 5: GNC and PNA Parking Map*).

### 5. Smoke Free Event

- a) Please note the Perth NAIDOC Carnival is a Smoke Free Event; therefore, no smoking is permitted on the grounds, in or around buildings.

### 6. Venue Clean Up Operations

- a) NWA will be hosting the Perth NAIDOC Netball Carnival across two venues: Gold Netball Centre and Perth Netball Association
- b) Venue clean-up and pack down procedures will commence immediately following the conclusion of the last match.
  - a. NWA encourage ALL teams to respect each court and where possible to be responsible for the cleaning of courts after each game
  - b. NWA encourage teams to nominate a representative of each team to be responsible for monitoring their team's hygiene.
  - c. Any assistance during this pack down and clean-up process would be appreciated but is not compulsory.

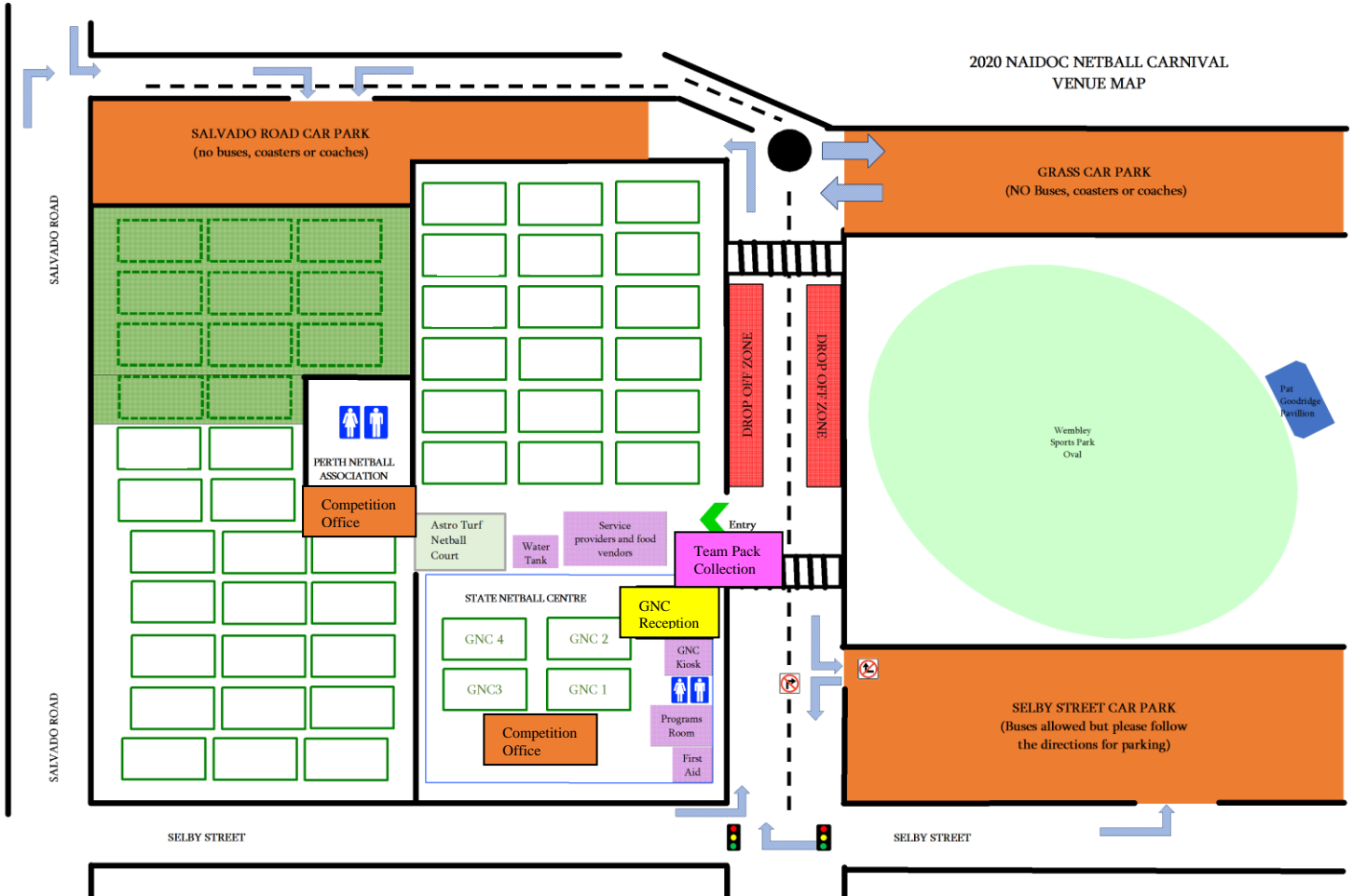

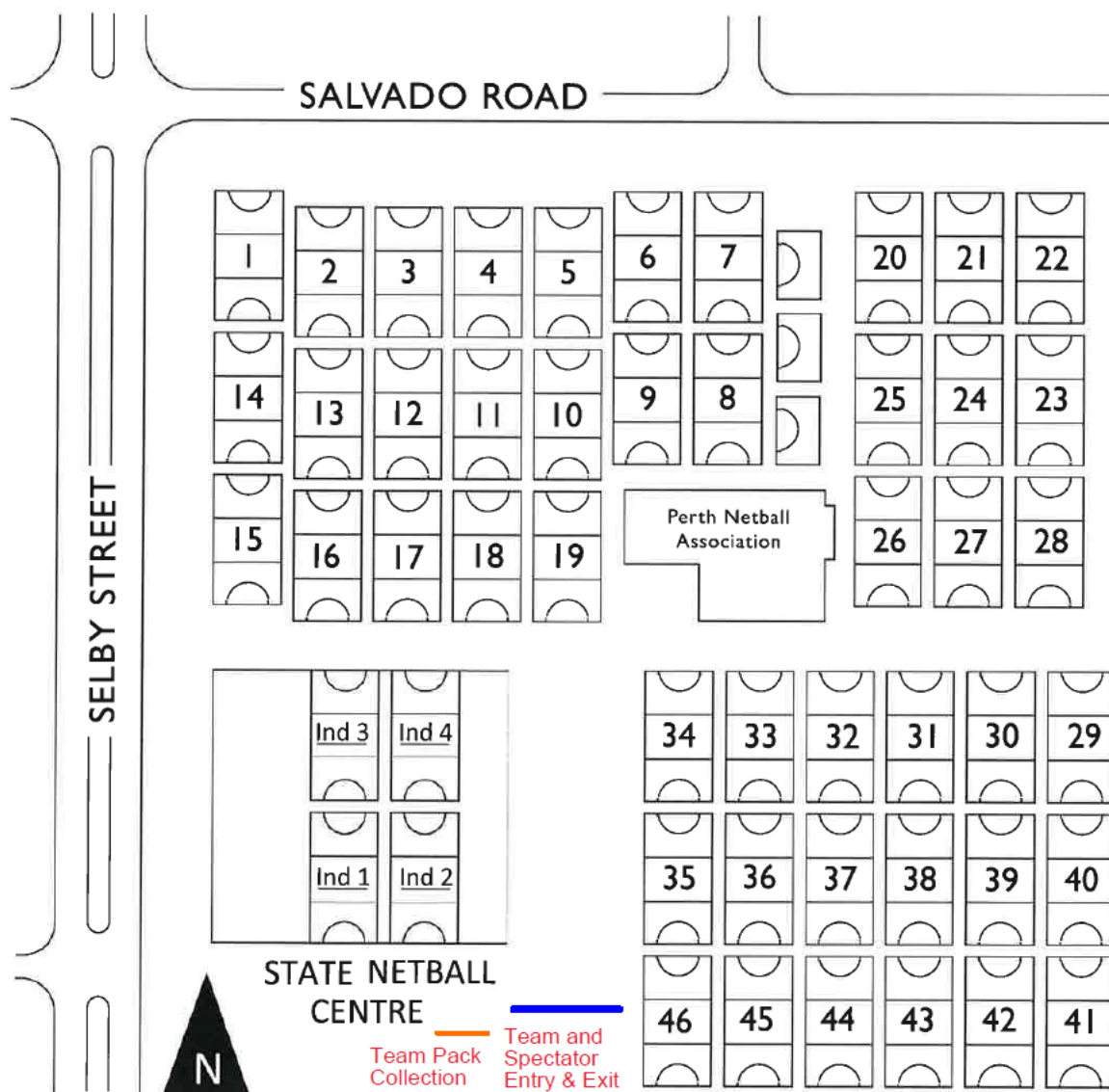

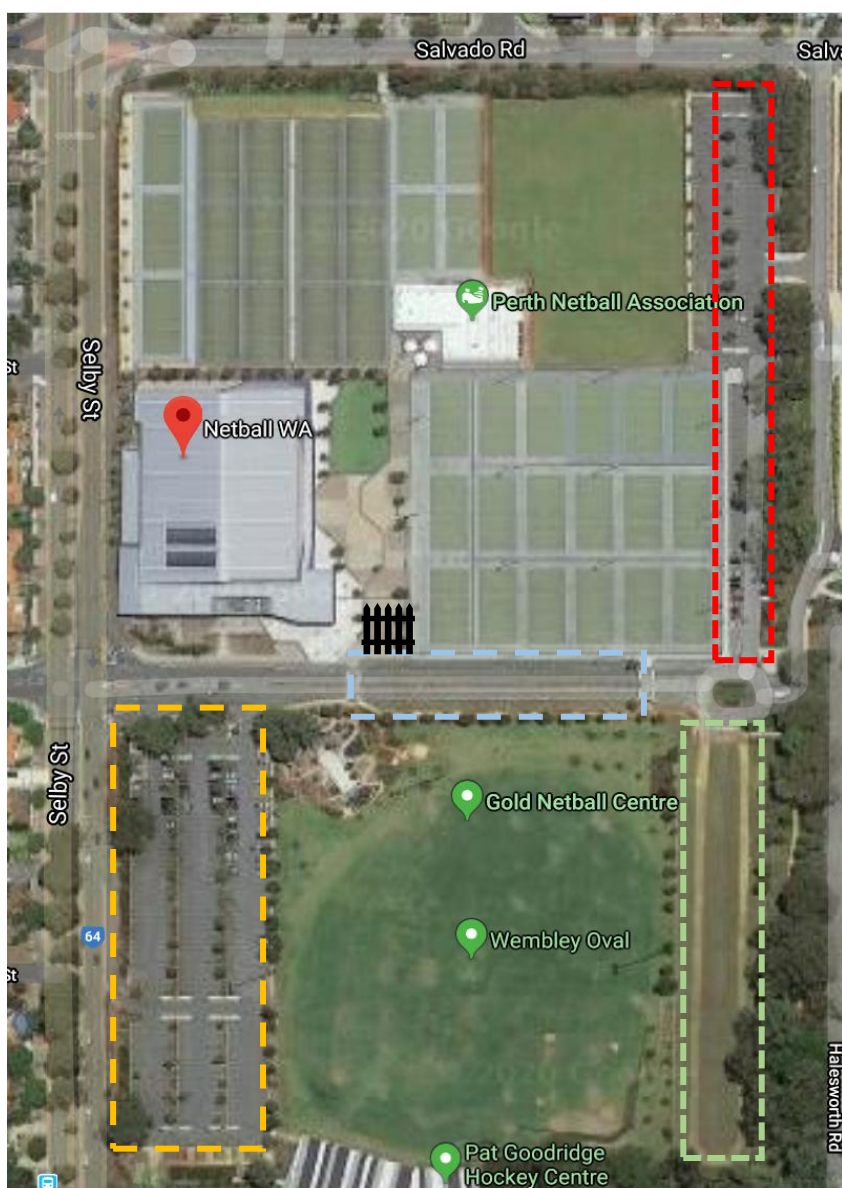




## Appendix 4: Entry and Exit Map
