



FREQUENTLY ASKED QUESTIONS - PHASE 4 CONTINUED

Should we download the SafeWA App?

It is strongly recommended that all participants install the SafeWA App to ensure that any active cases may be tracked and traced if they should arise.

What businesses will be required to maintain contact registers in relation to sport and recreation venues?

From 5 December 2020, the following businesses will be required to maintain contact registers for Health Department COVID-19 contact tracing:

- Food and licenced venues
- · Gyms, indoor sporting centres and pools
- Function centres
- Community facilities, libraries, and halls

Contact registration is encouraged but not mandatory for other businesses and gatherings. Please refer to the WA State Government Frequently Asked questions for more information on contact tracing. **Click here.**

Can my Clubroom (Including bars and restaurants) open?

Club rooms must comply with the 2sqm per person rule. Each venue must have a COVID Safety Plan that has been developed in consultation with its local government or venue owner. Patrons should where possible practice physical distancing. For all patrons 16 years and over, follow the venue requirements for contact tracing.

What Netball WA protocols do we have to abide by for Phase 4 Continued

Associations, clubs, teams, and participants must adhere to the following to ensure they are meeting WA State Government restrictions and NWA protocols, but most of all, are staying safe and limiting any potential spread of COVID-19.

- Update Phase 4 COVID-19 Safety plan to reflect updated requirements. Follow venue protocols at all times.
- Physical distancing of 1.5m is recommended where possible, good hygiene and 2sqm rule is applied to activities not included in the drills and match play.
- All equipment is permitted to be used. Hygiene protocols need to be followed.
- Adherence to NWA hygiene and or venue protocols at all times.

Are spectators allowed at training and games?

Yes, at the associations direction. Spectators may be limited to adhere to the 2sqm restrictions.

How does an association determine its spectator space?

To determine the spectator space is total venue space divided by 2. Designated fixed seating areas are determined in consultation with venue owner based on 2sqm guidelines.

Does the Association still require an Entry (Ingress) and Exit (Egress) Point/s on Match Days?

Refer to your Association COVID-19 Safety Plan- Phase 4. Please note that some venues are required to maintain separate Entry and Exit points.

What happens if there is a positive test in our group/team at training or in a match?

If there is a positive case within the team environment, then all participants, coaches and volunteers and coaches who have been in contact will need to self-isolate for 14 days and refer to the State Government health departments processes. If you are feeling unwell you should seek medical advice immediately by calling your GP and please do not attend training.
