







# 2022 FLO STARCEVICH MANAGERS SCHOLARSHIP

Netball WA, through the Flo Starcevich Managers Scholarship, aims to provide an opportunity for Netball WA affiliated managers from grass roots to elite level to further their managing aspirations.

Netball WA will make available an amount of \$1,500 to assist the manager to further their managing aspirations through education and personal development opportunities. This will assist and enhance the managers' ability to further their team managing knowledge and practices.

The following scholarships shall be awarded:

• 1 x Managers Scholarship

\$ 1,500 (ex GST)

# **Application Eligibility Criteria**

Scholarship Application Eligibility Criteria Applicants:

- be affiliated members of Netball WA;
- be 18 years of age or over;
- have a valid current Working with Children Check;
- be managing at Association, State or National level;
- be able to demonstrate how they will use the scholarship to further their team managing skills
- be familiar with Netball WA Strategic Plan and Vision and demonstrate the ability to support Netball WA values;
- adhere to Netball WA sponsorship guidelines when representing Netball WA at any event or whilst undertaking any activities as part of the scholarship.

Notes: Full-time employees of Netball WA, West Coast Fever and WAIS are ineligible for this scholarship.

## **Scholarship Duration**

The Flo Starcevich Managers Scholarship will be awarded and run for the period 1<sup>st</sup> April 2022 to 30<sup>th</sup> November 2022. Scholarships are generally a one-time award. However, if a scholarship recipient can show just reason and provide the selection panel with documentation as to why a scholarship should be renewed, then this may be considered. The scholarship recipient will be required to complete and submit an application annually. No scholarship recipient shall receive a scholarship for more than 2 years.

#### **Application Procedure**

2022 Flo Starcevich Managers Scholarship Applications will open on 15<sup>th</sup> December 2021 and close 8<sup>th</sup> March 2022.

Applications will be available for download from the Netball WA website and submitted via electronic submission.

Applications must be completed on the official application form with any requested supporting documentation attached and received by the due date. The selection panel will not consider late or incomplete applications.

# **Scholarship Promotion and Publicity**

The Scholarship holder must agree to photo and media articles regarding the appointment of their scholarship and/or articles of interest that may arise during their scholarship.

## **Selection Process and Appointment**

After due consideration of applications, the selection panel may (if they feel required) request personal interviews with the applicants either in person or via phone. The scholarships shall be appointed in accordance with the Flo Starcevich Scholarship Application Eligibility Criteria.

The Selection Panel for the Flo Starcevich Scholarship will be:

- West Coast Fever Talent Coordinator
- West Coast Fever Pathway Team Leader
- West Coast Fever Team Operations Manager

Netball WA's Chief Executive Officer will ratify successful applicants. Successful and unsuccessful applicants will be notified no later than 16<sup>th</sup> March 2022.

If no application is received, or the selection panel deems that an applicant(s), do not meet the specific scholarship selection criteria, then scholarship applications may be extended or may not be awarded for that calendar year.

## **Financial Distribution and Reporting**

Following the ratification of the relevant Flo Starcevich Managers Scholarship appointment the scholarship funds will be distributed to the recipient's bank account no later than 1<sup>st</sup> April 2022.

The Scholarship holder will be required to provide evidence of full expenditure including tax invoices along with a completed acquittal to Netball WA by 11<sup>th</sup> December 2022. Any unspent funds will be required to be returned to Netball WA. If it has been found that the recipient has spent funds not in accordance with the funding eligibility or cannot provide evidence of expenditure, then they will be required to refund that portion of funds to Netball WA.

#### **Scholarship Report**

At the completion of the Scholarship a written report describing outcomes against key performance indicators will be required to be submitted to Netball WA **by 19**<sup>th</sup> **December 2022** from cessation of scholarship.
