2. PRESIDENT'S ADDRESS:

The President, Craig Heatley, began his address by acknowledging the contribution of NWA Life Members, Association Presidents, and WANL Club Presidents, as well as the CEO, Simone Hansen, and all the Netball WA staff.

The President then introduced the current Directors on the Board of Netball WA and Glass Jar Australia thanked them for their commitment and professionalism. He also thanked the staff and members for their dedication in another successful year, highlighting the maiden premiership win by West Coast Fever.

The President advised that under the Constitution, the Delegate of each Tier 1 Association is entitled to one vote on each Motion put to this meeting.

3. CONFIRMATION OF MINUTES OF PREVIOUS ANNUAL GENERAL MEETING

The minutes of the prior Annual General Meeting, held on 12 May 2022, were noted and taken as read. The President called for any amendments to the minutes of Netball WA's 2022 Annual General Meeting – none were received.

4. ADOPTION OF ANNUAL REPORT

It was noted that the 2022 Annual Report had been circulated. The President provided an overview of the activities and successes of Netball WA, West Coast Fever and Shooting Stars, and thanked the Members, Associations, administrators, coaches, umpires and volunteers across the State for their continued support and commitment. The President highlighted the success of the Shooting Stars program which has continued to grow through 2022. He made a special mention of our partners, noting the important role they play in the success of the organisation.

The President called for questions from the membership in relation to the 2022 Annual Report. No questions were received.

5. ADOPTION OF AUDITED 2022 FINANCIAL STATEMENTS

The meeting noted that the audited 2022 Financial Statements for Netball WA had been circulated.

The CEO of Netball WA, Simone Hansen, presented an overview of key revenues and expenditure in 2022. It was noted that consolidated revenue for NWA & WCF was \$13.09M which is on par with 2021 (\$13.1M). The breakdown of this income was presented. The CEO stated that of the total consolidated revenue, NWA income was \$9M (2021: \$9.2M) and WCF income was \$4.1M (2021: 3.9M).

The CEO then presented the consolidated expenditure for NWA & WCF as \$13.2M compared to 2021 (\$13.4M) which is a reduction of 1.5%. WCF related expenditure was approx. \$4.2m, noting that this cost does not reflect an apportioned amount for salaries of corporate services staff across to WCF. A breakdown of the individual line items was presented, with the top ten expenditure items explained. The CEO concluded her presentation by explaining the 2022 deficit of \$74K is an improvement on the 2021 deficit of \$265K, despite some continuing impact from COVID-19 early in the year, and was better than the budgeted deficit of \$285k. The association is forecasting a profit of \$88K for the 2023 year.

The President thanked Simone Hansen, Netball WA's Audit & Finance Committee, chaired by Lisa Wynne and the NWA Finance Team for their work with the auditors, PFK Perth.

The CEO and President called for questions from the membership in relation to the 2022 Audited Financial Statements. No questions were received.

8. APPOINTMENT OF LIFE MEMBERS

The President noted that no successful nominations for Life Members were received this year, therefore no Life Members will be inducted for 2023.

The President paid tribute to the Life Members who sadly passed away in 2023.

9. CONFIRMATION OF APPOINTMENTS OF PATRON AND AUDITOR

The President explained that following His Excellency, the Honourable Kim Beazley, stepping down as Governor of Western Australia, no other patron had been approached. It had been decided that this role was deemed not necessary to the needs of the organisation and therefore, would not be filled at this stage.

The President announced that the NWA Audit & Finance Committee had endorsed the services of RSM as the new auditors for the 2023 Audit for NWA.

It was RESOLVED at the recommendation of Netball WA's Audit & Finance Committee and the NWA Board, that RSM be appointed as Netball WA's Auditor for the 2023 Financial Year.
