Netball WA (Inc) (**Netball WA**) has pleasure in inviting you to attend its 2025 Annual General Meeting (**AGM**) which will be held on **Thursday, 22 May 2025 at 6:30pm** at the Matthews Netball Centre, 200 Selby Street, Jolimont WA 6014 and via **Zoom Videoconference**.

BUSINESS OF THE MEETING

1. Receipt of Reports and Accounts

To receive and consider Netball WA's:

- a) Audited Financial Statements for the year ended 31 December 2024;
- b) Auditor's Report for the year ended 31 December 2024; and
- c) Annual Report for the year ended 31 December 2024.

<u>Note</u>: There is no requirement for Members to approve the Financial Statements and Reports.

In accordance with the Rules of Association of Netball WA (Rules of Association), Tier 1 Associations must submit any Notice of Motion for inclusion as special business at the AGM to Netball WA's CEO by no later than 5.00pm on Thursday, 17 April 2025.

ANNUAL GENERAL MEETING PARTICIPATION

In accordance with Rule 27.2 of the Rules of Association, each Voting Member shall advise Netball WA of its Delegate within fourteen (14) days of the appointment or any change, including the name, and contact details of the Delegate, and in any event, two (2) Business Days prior to the commencement of the AGM or the commencement of the electronic vote prior to the AGM (Voting opens: Thursday, 1 May 2025).

In accordance with Rule 5.1 of the Rules of Association:

- Tier 1 Associations shall be represented by their Delegate, who will be entitled to attend, speak, debate and vote on behalf of their Association at the AGM.
- Tier 2 and 3 Associations may appoint a representative to attend and speak at the AGM but will have no debating or voting rights.
- Affiliated Clubs may appoint a representative to attend the AGM but will have no right to speak, debate or vote.
- Individual Members will have the right to attend the AGM but will have no right to speak, debate or vote.
- Life Members may attend and speak at the AGM but will have no right to debate or vote.
