### ADOPTION OF ANNUAL REPORT 4.

It was noted that the 2023 Annual Report had been circulated and uploaded to the website. As such the report has been taken as read. The Chair called for questions from the membership in relation to the 2023 Annual Report. No questions were received.

### 5. **ADOPTION OF AUDITED 2023 FINANCIAL STATEMENTS**

The meeting noted that the audited 2023 Financial Statements and Auditor's report for Netball WA had been circulated and, as such, taken as read.

The Group CEO of Netball WA, Simone Hansen, presented an overview of key revenues and expenditure in 2023. It was noted that consolidated revenue for NWA & WCF was \$15.02M which is a 15% increase on 2022 (\$13.09M) of \$1.93M. The Group CEO stated that of the total consolidated revenue, NWA income was \$10.1M (2022: \$9.0M) and WCF income was \$4.9M (2022: \$4.1M). It was then explained that the consolidated expenditure for NWA & WCF was \$14.7M compared to 2022 (\$13.2M), which is an increase of 12% (\$1.6M). The breakdown of both income and expenditure was presented in more detail. In summary, the 2023 surplus of \$307K is a significant improvement on the 2022 deficit of \$74K and was higher than the budgeted surplus of \$88k.

The Group CEO concluded her presentation by explaining the Association continues to maintain a healthy cash position of approximately \$3M on an ongoing basis. Finally, it was noted the Association is forecasting a surplus of \$22K for the 2024 year. After a query, further discussion on the payment of FBT was explained in detail, as this was a large expense in 2023. The Group CEO confirmed that we remain focused on creating a business that is sustainable from a revenue and cost perspective, so that ideally we are able to make a small profit on a year to year basis.

The Chair thanked Simone Hansen, Netball WA's Audit & Risk Committee, chaired by Lisa Wynne and the NWA Finance Team for their work with the auditors, RSM.

The Group CEO and Chair called for any further questions from the membership in relation to the 2023 Audited Financial Statements. No questions were received.

The Chair announced that the NWA Audit & Risk Committee had endorsed the services of RSM as the new auditors for the 2024 Audit for NWA.

It was RESOLVED at the recommendation of Netball WA's Audit & Risk Committee and the NWA Board, that RSM be appointed as Netball WA's Auditor for the 2024 Financial Year.
