Policy Statement

Netball WA is the governing body for netball in Western Australia. Members are the greatest asset and make a significant contribution towards delivery of our sport. It is important that a strong membership base is encouraged and maintained in accordance with the objects outlined in the Rules of Association (Constitution).

Scope

This Policy applies to all members of Netball WA. This includes Member Associations, Member Entities, Affiliated Clubs, Individual Members, and Life Members.

Purpose

The purpose of this Policy is to:

- Define the Registration Types that confer Membership to Netball WA as per the Netball WA Rules of Association [March 2025].
- Define the Membership categories and the eligibility criteria for each Membership category.
- Confirm who is not a member.

Implementation

1. Membership

- 1.1 The following registration types confer membership of Netball WA:
 - a. Member Associations;
 - b. Affiliated Clubs;
 - c. Member Entity;

- d. Individual Members; and
- e. Life Members.
- 1.2 Program Participant registrations do not confer membership of Netball WA.
- 1.3 The procedures for becoming a member or participant of Netball WA are defined in the NWA-PRO-05 Affiliation & Membership Procedures.

2. Membership Categories

- 2.1 The Netball WA Membership categories are:
 - a. Tier 1 Member Association
 - b. Tier 2 Member Association
 - c. Tier 3 Member Association
 - d. Tier 4 Member Entity
- 2.2 Membership category criteria may be added to or amended by Netball WA from time to time in accordance with this Policy.

3. Membership Schedule – Member Associations and Member Entities

3.1 Member Associations and Member Entities must meet the relevant criteria to be eligible for membership status.

5. Individual Members

- 5.1 Individual Members must meet the following criteria to be eligible for their membership:
 - a. Compliant with all Netball Australia Policies, Statements and guidelines
 - b. Abide by the official rules of World Netball and the interpretation as determined by Netball Australia and /or Netball WA
 - c. Agree to and comply with Netball Australia's codes of conduct.

6. Netball WA Life Members

- 6.1 The Life Membership Policy (NWA -POL-28) sets out:
 - a. Criteria and procedure for appointing a Life Member; and
 - b. Conditions, obligations and privileges of Life membership to Netball WA.

7. Membership Renewal

- 7.1 Member Associations shall:
 - a. renew their membership with Netball WA in accordance with the procedures applicable from time to time;
 - b. otherwise remain affiliated financial members of Netball WA in accordance with the procedures applicable from time to time; and
 - c. pay the annual fees prescribed by Netball WA from time to time.
- 7.2 Individual Members shall:
 - a. renew their membership with Netball WA and the Member Association in accordance with the procedures applicable from time to time;
 - b. otherwise remain affiliated financial members of their Member Association in accordance with the procedures applicable from time to time; and

c. pay the annual fees prescribed by Netball WA from time to time.

8. Criteria Disputes

8.1 To resolve any dispute regarding a member's compliance with the criteria or this Policy, refer to the Netball WA Rules of Association.

Definitions

Affiliated Club	A registered financial club of a Member Association.
Affiliation & Membership Procedures	Netball WA Affiliation & Membership Procedures document (NWA-PRO-05)
Competitions	Netball WA sanctioned competitive netball games.
Gold Industry Group West Australian Netball League Club (or GIG WANL Club)	A netball club that Netball WA grants a licence to participate in the Gold Industry Group West Australian Netball League (GIG WANL).
Independent NetSetGo Centre	A Member Entity that delivers the Woolworths NetSetGo program only
Individual Member	An affiliated financial individual Playing Member of a Member Association or Member Entity or a Non-Playing Member recognised as a member under the Netball WA Rules.
Life Member	A person upon whom life membership of Netball WA has been conferred by the Board under the Life Membership Policy and Netball WA Rules.
Member Association	An Association which is recognised as an affiliated member of Netball WA as prescribed in the Netball WA Rules.
Member Entity	An Association with only Non-Playing Members and/or volunteers, GIG WANL Club, Independent NetSetGo Centre or any other approved affiliate of Netball WA who has been approved under the Tier 4 Membership category as prescribed in the Netball WA Constitution.
Netball WA	The association referred to in the Netball WA Rules.
Netball WA Annual Affiliation Membership Agreement	The annual affiliation agreement between Netball WA and a Member Association or Member Entity.
